<b>General Secretary</b> Sri S.C.Jain	We wish to invite your kind attention on the recent judgement of Karnataka High Court in the matter of payment of benefit under Regulation No. 29(5) of Pension Regulations applicable to bank retirees wherein Chief Justice Shri Vikramjit Sen and Justice B.V.Nagrathan ,while dismissing writ appeals of the bank management, have ordered payment of cost of Rs. 10000 to the retirees of State Bank of Mysore for appealing without merit and has passed the following structure against the bank management;

You may be perhaps aware that issue of payment of benefit under Regulation No. 29 (5) to VRS Optees under special scheme 2000 was dealt and decided by the Supreme Court in Mohandas V/S Bank of India case in the year 2009 and accordingly Indian Bank of Association ( IBA) was kind enough to advise banks to pass on the benefit with arrear to the eligible retirees. On receipt of IBA advise, all banks except Vijay Bank,Allahabad Bank and subsidiaries of SBI have implemented the court order and passed on the benefit to the retirees.

It is matter of regret that managements of the above banks have been unnecessarily and without any logical reasons dragging the matter by filing appeals in the courts and thereby denying legally valid claims of retirees of these banks. It is nothing but avoidable harassment to senior citizens and criminal waste of public money to maintain false ego of certain individuals occupying senior positions in banks.
