BENGALURU BECKONS YOU TO THE 6TH CONFERENCE OF AIBRE

DELEGATES ENTITLEMENT, DELEGATE FEES, LAST DATE FOR SUBMISSION OF LIST OF DELEGATES AND LODGING ARRANGEMENTS:

AIBRF central office has already informed all the units about their entitlement of Delegates and Observers, vide Circular No. 2022/657 dated 26th August, 2022. All affiliates are advised by the Central Office to submit a list of delegates and observers to Central Office of AIBRF with a Copy to our State Committee, latest by 15.11. 2022.

As communicated by Central Office Circular No.2022/657 dated 26/8/2022, delegate and observer fee is Rs. 5000/ per head. We request all affiliates to pay the delegate and observer fee to the account of our state committee, as detailed at the end of this communication and submit their list of delegates and observers along with details and mode of payment of fees to the address furnished at the last part of this communication, on or before 15th November,2022, to enable us to make necessary arrangements in this connection.

We request all participants to make arrangements for their travel. Bangalore is well connected by Road, Railways and Flights from all cities.

Lodging arrangements will be made by our State Committee as follows:

- 1. For Delegates and Observers coming from North India and From Mumbai (Reaching Bengaluru on 24th February afternoon): Lodging in Hotels for three nights, i.e. on 24th, 25th and 26th, February, 2023.
- 2. For Delegates and Observers from Southern States(Reaching Bengaluru on 25th): Lodging in Hotels for two Nights, i.e. on 25th and 26th February, 2023.
- 3. In exceptional cases, if train/ bus/ flight timings warrant so, these arrangements may be modified in consultation with Central Office of AIBRF.
- 4. If any of the delegates/observers propose to bring their spouse, it will be permitted, with additional payment of Rs. 5000/

For the purpose of providing lodging arrangements, General Secretaries of affiliated units are requested to furnish us in a tabular format, the following particulars, on their letter head:

- 1. Name of the delegate/observer.
- 2. Age.
- 3. Aadhar card number
- 4. Whatsapp phone number
- 5. Date and time of Arrival at Bangalore, with train number/flight number/ originating point of bus.
- 6. Date and time of departure from hotel after the conference
- 7. Additional information/request if any, like Physically Challenged, etc

Detailed communications regarding Lodging and Boarding, arrangements and timings of the Conference, Local Transportation, tourist places in and around Bangalore, etc will be issued in due course of time.
