Re: Hearing at Deputy Chief Labour Commissioner (Central) on 24.01.2017 at Mumbai

We request you to refer our circular No. 2016/615 dated 30.12.2016 advising that Deputy Chief Labour Commissioner has fixed date of 24.01.2017 in his office at Mumbai for JOINT DISCUSSION with IBA and Unions on the basis of representation submitted by AIBRF. AIBRF representatives have also been invited to participate in this Joint Discussion. Copy of the letter received from DCLC in this regard is enclosed for your information.

2. Comrades, you will kindly agree that this is significant move forward towards our long pending demand that IBA should hold discussion on pending demands of retirees with AIBRF. We have been making efforts in this direction for quite some time. Now ultimately with the intervention of CLC , Joint Discussion will take place on our demand of 100 percent DA to the pensioners retired prior to November 2002 where AIBRF will present its stand on behalf of the retirees.

3. After submission of our representation to CLC on this, through Whatsapp/ Social Media , news is getting spread that AIBRF is raising the issue of 100 percent DA only for those pensioners retired between 1998 to 2002. We may clarify that this news is not correct and baseless.

4. In fact, we may add for your information that we have submitted detailed note to CLC based on which we shall be presenting our stand in this matter pointing out the legal lacuna noticed in implementing 100 DA formula under 8th wage settlement in 2005 and have submitted 4 prayers to CLC (last Para of the note) for consideration and passing the suitable order on it.
