**Re: 100 Percent Dearness Relief to Pre-November 2002  
Retirees**

**We request you to refer Record Note dated 25.05.2015 signed between IBA and 9 Unions on the pending issues of retirees, in particular the following Para on 100 percent Dearness Relief to Pre- November 2002 Retirees**

**" From a humanitarian point of view, IBA may examine feasibility of providing 100 percent Dearness Relief to Pre – November retirees based on detailed costing factor"**

**2. As you know, more than 2 months have passed since signing of the above referred Record Note. We learn that wage settlement signed for the employees has also been implemented and concerned employees have also been paid arrears in almost all banks.**

**3. IBA and UFBU have identified 100 percent DR to Pre-November 2002 as "Humanitarian Issue" in the Record Note. Therefore it becomes imperative on both the parties to dispose the matter with urgency and priority without any delay as this matter , as you are aware , is pending for last more than 10 years and more than 40000 pensioners belonging to this group out of total about 1 lakhs have left this world without getting justice on the issue and the surviving are facing financial hardship in the absence of benefit of 100 percent DR for last 10 years.**

**4. We find from contents of the Record Note as well the communications issued by UFBU on this matter during rounds of negotiation that this matter has been discussed and dealt in depth during wage negation. We learn that even the recommendations on this matter were sent to the government for approval in the past. In this background, it should not be**
