election is necessitated because of more than one nomination for any post, the following procedure will be followed.

- (a) In first round election process will be carried out for the posts of the Chairman, President and General Secretary**
- (b) The delegate who desirous to contest the election for any of the above three posts should file the nomination by giving complete details about himself/ herself like name, name of organisation, delegate number allotted by the Reception Committee etc along with the name of the post for which he wants to file the nomination and deposit it with the Election Commissioner or with the official authorised by him by 10 AM on 27th November 2015.**
- (c) In case Election Commissioner receives more than one nomination for any of the above three posts within stipulated time it will be announced by 3.00 PM on 27.11.2015.**
- (d) In the above event the delegates should collect secret ballot papers from the counters opened for this purpose and cast their votes by 7.30PM on 27.11.2015 by putting their ballot papers in the box kept for this purpose.**
- (e) The Election Commissioner will announce the result on 28.11.2015.**
- (f) Election for remaining posts will be held through consensus in consultation with the affiliates keeping in mind the membership strength, geographical considerations and suitability of individuals. In case this mechanism does not work, elections will be held as per the above process in the second round.**

We seek cooperation of all delegates, our affiliates and their functionaries in smooth conduct of the election process within the stipulated time limit of the conference to keep high tradition of the organisation.
