### Re: HOLDING DISCUSSION WITH AIBRF

We request you to refer our letter no 2016/436 dated 28.05.2016 and letter no 2016/451 dated 04.06.2016 addressed to Indian Bank Association requesting them to clarify the position on holding discussion with another retiree organisation on 26.06.2016 and demanding that IBA should also hold discussion with AIBRF in view of reported change in their stand in holding the discussion with the retiree organisations.

2. We have since received response from IBA on the subject Vide letter No. HR&IR/KU/G5/429 dated 02.06.2016 ( copy enclosed) wherein it is clarified that IBA continues to pursue policy of not holding discussion with the retiree organisations in the absence of specific mandate from member banks and the discussion of 26.05.2016 was purely informal which may take place when any entity comes for submission of memorandum.

3. In this connection, it may be mentioned that in the past on the following occasions, AIBRF delegations met IBA Officials and held informal discussions.

(a) AIBRF delegation met IBA Chairman on 25.05.2015, submitted the memorandum on retiree demands followed by detailed informal discussion with the Chief Executive, IBA Shri M.V.Tanksale after observing Protest Day at Azad Maiden, Mumbai.

(b) AIBRF delegation second time met IBA Chief Executive Shri M.V.Tanksale on 10.02.2016 and held informal discussion on retiree issues after observing Protest Day -2 at Azad Maiden, Mumbai.

**4. Further, we add that on both the occasions we had issued communications on the subject to the point, brief and without any exaggeration for the information of the membership ensuring that undue hopes are not raised due to such informal meetings.**

5. Comrades, AIBRF shall continue to struggle till IBA changes its present policy of not inviting retiree organisations in the absence of
