FOLLOW UP ACTION**

You are aware that on the call given by AIBRF during the months of May and June 2016, about 25000 members had sent online representations to Prime Minister Office on pending demands of bank retirees. It was one of the very successful action programmes of AIBRF.

2. We understand that members have since started receiving response from PMO on their online representations. It is seen from contents of the reply that PMO office has simply forwarded reply prepared by IBA at the junior level without any vetting at their end. This routine reply has resulted into dissatisfaction and resentment among the membership. We find that members have given poor/ dissatisfied rating on the replies as a feedback sought by PMO.

3. In view of the above position, the undersigned has again sent representation dated 07.08.2016 (copy enclosed) as a follow up and pursue the matter further at PMO level. It has been sent on individual capacity as system accepts individual representation only. The grievance has since been registered under no PMOPG/E/2016/0279847.
