In view of the above, AIBRF in its Central Committee Meeting held at Nagpur recently has decided to launch next phase of action programmes in support of the pending issues during the months of November & December, 2016. Action programmes to be organised include submission of Memorandum to more than 300 Members of Parliament, meeting Central Ministers in delegations to draw their attention and seek their intervention on the issues and holding Hunger Strike at more than 100 centres in the country besides holding Massive Centralised Dharna Programme in Delhi during the next Budget Session of the Parliament.
