Dear Comrades

Re MEETING WITH IBA

As you are aware that we have approached IBA several times in the past that it should discuss with the representatives of retirees to discuss their issues and they should be given opportunity to present their views on the pension related issues and other relevant matters. However IBA has been refusing to meet us.

2. In view of this we had written detailed letter to the Department of Financial Services in the month of October 2012 followed by the meeting with the Director, Banking in the month of February, 2013 when we requested the government that IBA should be asked to hold discussion with the retirees so their pending issues can be resolved without delay and litigation.

3. We are pleased to inform you that the Department of Financial Services, Government of India has written letter no. 10/30/IG/2013-IR dated 11.06.2013 asking IBA to hold discussion with the retirees.

4. On the basis of the above referred letter of the government, we have written to the Chairman, IBA (copy enclosed) seeking time for the meeting. We hope in view of the government directives; we shall be invited for discussion. We shall advise further developments in the matter in the due course.

5. This development which we consider significant one could be possible because of continuous efforts made by AIBRF.
