**Re: AIBRF Action Programs to be launched from 15.10.2022 in support of  
Demand of Updation of Pension**

We request you to refer our circular No. 2022/671 dated 24.09.2022 giving detailed action plan to be launched from 15.10.2022 in support of our demand of Updation of pension as per the unanimous decision taken in the last office bearers' meeting

**2. One of the points of action plan is to submit online Appeal/ Representation to Honorable Prime Minister, Shri Narendra Modi by individual pensioners.**

3. We have since finalized details of steps to be taken to implement this point of Action Programs. Details are as under

**(a) The program will be launched from 15.10.2022**

(b) Retirees are called upon to submit online Appeal/ Representation to the Prime Minister

(c) Format of Appeal is enclosed which is to be used by retirees is enclosed.

**(d) The following steps will be required to be taken by the individuals to submit online Appeal. (i)Open PM India site on Google (ii) Go into "Interact with PM" Menu (iii) then, open "write to PM" Menu (iv) Fill up Mobile No. and/or E-Mail ID (V) System will generate OTP and will be intimated on the registered mobile (vi) Fill up OTP on the site (vii) Next menu will get open where appeal can be submitted.(viii) Reference No and acknowledgement of the application will be intimated on registered Mobile/E-Mail which can be used.**

(e) State Committees / Affiliates are advised to take steps to create awareness among members by issuing circulars/ convening video meetings/ what Sapp messages etc. Vigorous publicity is needed. State Committee/ Affiliates may form committees at various levels who should monitor for effective implementation of the program. **We expect at macro level to submit minimum 60000 On Line Appeal to PMO up to 31.12.2022 (20 per cent of AIBRF total membership).**

(f) It is very important action program to pursue demand of Updation as we are directly approaching to the highest authority of the country which matter the most. Therefore full involvement of our teams needs to be hardly emphasized.

(g) Proper record of the online submission may be maintained at State Committee/ Affiliate level. Fortnightly report may be sent to Central Office.

**(h) AIBRF is on Mission. Our Commitment to the cause is our strength.**


