Re: Action Programs of AIBRF in support of Updation of Pension Issue

We invite your attention on our circular letter No. 2022/611 dated 11/03/2022 giving call of submitting memorandum to MDs of Banks/ Zonal Managers / other authorities by state committees during the months of March & April, 2022 and organize Dharna programs at various centers.

2. On the basis of reports received from State Committees, we find many state committees have become active on this count and have met MDs of Banks/ Zonal Managers in delegations and submitted memorandum on Updation to them with the request to forward the same to IBA with their recommendations for early approval of Updation for the retirees. Brief Reports in this regard is submitted below

- (a) On 19.04.2022 AIBRF, North West State Committee delegation led by Shri Devendra Singh Jattana, Organising Secretary, AIBRF and GS North West State Committee accompanied by Shri Anil Sood, Canara Bank, Shri O.P.Ummat, PNB Shri G.P. - (b) On 19.04.2022, Office Bearers of AIBRF and some activists of DSC-AIBRF, DGS, Shri A.K. Bansal, DGS, Shri Mitra Vashu DGS, Comrade Suresh Sharma, Comrade Vijay Juneja, Org Secretaries, AIBRF, Comrade B.P. Singh, Comrade A.S. Maan, Comrade S.C, Sharma, leaders of DSC-AIBRF , visited the **MD & CEO's Office of P&S Bank and met M.D. Sri S Krishan** and handed over the Memorandum of AIBRF regarding Pension Updation to him. We had requested him to forward the Memorandum to IBA with MD & CEO's recommendations. He had listened our views very patiently and assured to forward our memorandum to IBA, Chairman for further action.
