As all of you are aware, commencing from Labor Day, AIBRF has launched very important and mass action program of submission of Memorandum on updation to all Members of Parliament from Lok Sabha & Rajya Sabha on-line with the request to them to use their good offices for immediate resolution of bank retirees' long pending demand of pension updation for which more than 5 lakhs retirees have been waiting for last 20 years.

3. We are very happy to inform that responding to the organizational call, Core Committee Members and Sate Committees of AIBRF on first day itself have submitted memorandum to 129 Members of Parliament , details of which are as under



All concerns are requested to presently concentrate with full attention and concentration to make this program successful.

We are happy to inform that in addition to the above action program, **North West state committee** have been organizing Dharna programs in support of Pension Updatation at various centers in Punjab & Haryana states for last one and half months along with submission of memorandum on updatation to Members of Parliament of the area.
