### **Re: Revised FAQ on Super Top Policy of Go Digit**

FAQ issued earlier was not found very specific leading to some confusion among retirees on certain points. The matter was discussed with KMD/ Go Digit and based on the interaction we had, it has been suitably revised to make it specific and clear.

2. We enclosed revised FAQ for the ready reference of the members so they can take informed decision to join the scheme. It may be mentioned the revised FAQ released has consent and approval of the insurance company. You are requested to circular among the members/ retirees.

3. We have received some clarifications on operational issues from KMD which are reproduced below.

### **Communication From KMD**

Dear Sir

Our software is now fully functional, and we have removed all the problems the retirees have faced. We have also ensured that we inform the retirees who have faced the troubles earlier. However if we have missed anyone please do inform them

Kindly note that many of the persons have been trying another link which has been wrongly shared by some other persons and these persons are having a difficulty in logging in. I request you all to please share the correct link to all.

We from our side are sending as many WhatsApp messages to all.

As the word is spreading, there are many retirees who want to benefit by taking this most important policy which will take care of the rising costs of hospitalization. I request you all to spread this communication to one and all.

As mentioned earlier Any Bank Retiree along with the spouse can take the Standalone Go Digit Super Top up policy. The Super Top up policy has a threshold / deductible of 3 lakhs and sum insured of 1 lakh to 10 lakhs. The following Retirees / Pensioners/ Resignees/ Family Pensioners can take the policies

If they have taken a base policy of IBA whether as award staff or as an officer

1. If they have taken a Bancassurance policy from the bank
2. If they have their own individual policy
3. If they are covered as dependent parents with their children
4. Even if a person does not have any base policy, they can take a super top up policy. The first 3 lakhs of the first claim shall have to be borne by them post that this coverage can be taken.

We hope to make this one of the largest Standalone Super top up policy – a unique policy specially designed for your Associations”
