Re: Details of Action Programs Being Conducted Across the Country

Nationwide action programs are being organised by bank retirees under the banner of **AIBRF / UFBRO** to draw the attention of the Government of India and the Indian Banks' Association (IBA) towards the long-pending demand for **Pension Updation** and other issues concerning bank retirees, seeking their early and just resolution.

Since **20th November 2025**, Dharna and demonstration programs have been organised in **28 cities across the country** by the State Committees of AIBRF. A large number of bank retirees have participated in these programs, expressing deep resentment and anguish over the inordinate delay in implementing pension updation on the lines of the Reserve Bank of India.

These programs have received **wide coverage in both print and electronic media**, with reports appearing in more than **100 newspapers** across the country. At the conclusion of each program, memoranda highlighting the retirees' demands have been submitted to the **Indian Banks' Association and other concerned authorities**.

Simultaneously, AIBRF has also launched a program of submitting memoranda to **Members of Parliament and Union Ministers**, requesting them to raise the issue during the forthcoming session of Parliament and to impress upon the Government for early resolution. So far, memoranda have been submitted to **62 Members of Parliament**, many of whom have assured us that they will take up the matter with the Government and raise it in Parliament.

The programs conducted so far have been **highly successful and encouraging**, and have largely served the purpose for which they were launched.

We are pleased to submit below the **second report on the action programs** carried out across the country. We also convey our **sincere thanks and appreciation to all State Committees and their teams** for organizing these programs successfully and mobilizing retirees in large numbers.

The action programs will be **further intensified and continued until the long-pending issues of bank retirees are resolved.**

येत्या ३३ वर्षांपासून बँक कर्मचाऱ्यांच्या पेन्शन करानुसार मासिक पेन्शनमध्ये सुधारणा झालेली नाही. या अर्हात अशा अनेक मागण्यांकरिता अखिल भारतीय निवृत्त बँक कर्मचारी संघटनेच्या सेवानिवृत्त कर्मचाऱ्यांनी जिल्हाधिकारी कार्यालयासमोर धरणे आंदोलन केले. आपल्या मागण्यांचे निवेदन नायब तहसीलदार नक्षत्रा चौकते यांना देण्यात आले.

सेवानिवृत्त कर्मचाऱ्यांना मिळणारे निवृत्ती वेतन अतिशय तुटपुंजे आहे. इतर अनेक संस्थांमध्ये मात्र त्यांना त्यांच्या नवीन वेतन आयोगाच्या पगार वाडीनुसार आणिअथ पेन्शन वाड मिळते आहे. मात्र निवृत्त बँक कर्मचारी व अधिकारी यांना तशी वाड मिळत नाही. या महत्त्वाच्या मुद्याकडे सरकार जागृतचुनून दुर्लक्ष करित आहे. आज सर्व राष्ट्रीयकृत बँका सरकारला वर्षात २.०० लाख कोटी रुपये फायदा देत आहेत.

देशभरात, साडेतीन लाखपेक्षा जास्त कर्मचारी संघटनेची निगडित आहेत.



कोल्हापूर : बँक कर्मचाऱ्यांच्या पेन्शन करानुसार मासिक पेन्शनमध्ये सुधारणा झालेली नाही. यासह अनेक मागण्यांकरिता अखिल भारतीय निवृत्त बँक कर्मचारी संघटनेच्या सेवानिवृत्त कर्मचाऱ्यांनी जिल्हाधिकारी कार्यालया समोर धरणे आंदोलन केले.

गणना करणे, निवृत्त कर्मचाऱ्यांसाठी गुप्त आरोग्य विमा पॉलिसीवरील जीएसटी माफ करणे, इंडियन बँक्स असोसिएशनच्या अधिपत्याखाली निवृत्त कर्मचाऱ्यांसाठी सर्वोच्च स्तरावरील तडव्य निवारण यंत्रणा निर्माण करणे, खाजगी क्षेत्रातील बँकांच्या पेन्शनधारकांना 'एम्स-रेशिया' देयक अदा करणे, किमान पेन्शन दरमहा १०
