Subject: Invitation of Suggestions for Amendments to the Constitution of AIBRF and Draft Resolutions for the 7th Triennial Conference

Dear Sir,

We invite your kind attention to Circular No. **2026/0165 dated 25 May 2026** titled "**Notice of the Triennial Conference/General Council of AIBRF and Decisions of the Core Committee Meeting held on 25 May 2026.**" The circular informed all affiliates that a **Constitution & Resolution Drafting Committee** has been constituted to review the existing Constitution of AIBRF and prepare draft resolutions for consideration by the forthcoming Triennial Conference.

2.Subsequently, vide Letter No. **2026/0169 dated 02 June 2026**, the General Secretary has advised that the Committee is required to complete its work and submit its report together with the proposed amendments to the Constitution by **30 September 2026**, so that the same may be placed before the Central Committee and thereafter before the Delegates of the 7th Triennial Conference for approval.

3.The Constitution of AIBRF is the basic charter governing the functioning of our Federation. Keeping in view the organisational growth of AIBRF, changing circumstances and future challenges, it is essential that the Constitution is reviewed from time to time so that it continues to meet the present and future needs of the organisation.

Accordingly, all Office Bearers, Central Committee Members, State Committee Chiefs and affiliated organisations are requested to examine the existing Constitution carefully and send their considered suggestions regarding:

1. Amendments, additions or deletions proposed in the Constitution of AIBRF.
2. Any organisational issue requiring incorporation in the Constitution.
3. Suggestions for drafting resolutions to be placed before the 7th Triennial Conference.
4. Any other proposal which, in your opinion, will strengthen the democratic functioning, organisational efficiency and future growth of AIBRF.

Your suggestions should be **specific**, supported by reasons wherever possible, and may clearly indicate the relevant Article or Clause of the Constitution proposed to be amended.
