Re; Office Bearers Meeting scheduled to be held on 29.08.2026

Re; Note on Pension Updation

Please refer to AIBRF Letter No. **2026/204 dated 09.08.2026**, advising the rescheduled date of the Office Bearers' Meeting on **29.08.2026**, and AIBRF Circular No. **2026/198 dated 01.08.2026**, prescribing the agenda items for discussion at the meeting.

2. One of the important agenda items before the meeting is **"Identification of retiree demands for the next settlement and preparation of an appropriate action plan, with particular reference to the demand for pension updation."** The issue of pension updation has remained the most important and long-pending demand of bank retirees and therefore requires focused consideration and a well-coordinated organisational strategy.

3. In this connection, we are enclosing a **Note on various crucial aspects of Pension Updation**, covering the background of the issue, the present position, the justification for updation, the concerns of pensioners and the broad approach required to pursue the demand effectively.

4. We are also enclosing the **detailed Action Plan for pursuing the demand for Pension Updation at the organisational level**, which was circulated earlier vide AIBRF Circular No.

2026/0163 dated 21.05.2026 under the “**AIBRF National Campaign for Pension Updation.**” The said Action Plan contains various organisational, representational and campaign-related initiatives proposed to be undertaken for building sustained pressure for settlement of this important demand.

5. These documents are being placed before the Office Bearers with the objective that they may serve as a **base document for discussion and deliberation** on the agenda item relating to pension updation. It is suggested that, after considering the various aspects of the issue and the experience gained during the National Campaign, the Office Bearers may identify the priorities, decide the further course of action and evolve a **time-bound and result-oriented action plan** for the coming period.

6. The demand for pension updation has acquired greater urgency in view of the prolonged period for which the existing pension has remained without updation and the increasing financial and social difficulties being faced by a large section of retired bank employees. It is, therefore, necessary that the organisation should approach the issue with **unity, continuity, sustained follow-up and appropriate escalation at different levels.**

7. We request the Office Bearers to kindly go through the enclosed Note and Action Plan before the meeting so that the matter can be discussed meaningfully and the meeting can arrive at appropriate decisions on the future strategy for pursuing the demand of **Pension Updation.**
