**Re: Launching of Second Phase of Action programs in support of Updation
And other pending issues of Retirees
Re: Inviting Suggestions**

We request you to refer our circular No. 2025/0052 dated 02.07.2025 advising proceedings of the Office Bearers' Committee meeting held through video conferencing on 26th & 27th June and 1st July, 2025.

2. One of the decisions taken in the meeting was to launch **SECOND PHASE** of action programs in support of demand of Updation and other pending demands/ issues of retirees. In this regard we request you to refer Para 3(b) of the above referred circular.

3. In organizing first phase of programs and making them successful, state committees of AIBRF played very important role. We once again convey our sincere thanks to state committee leadership for organizing highly successful programs.

4. We request state committee leadership to collect suggestions from their teams on what should be format of second phase of Action programs and send to us so they may be taken in to account at the time of finalizing the programs. Following points may be considered during the deliberations in the matter at your end

- (a) Action programs should be organized in phased manner as done during first phase or they may be organized in one go on predetermined date at all centers.
- (b) What should be probable date for launching the second phase to make it effective and to ensure suitability for membership.
- (c) Format of the programs -Demonstrations, Rallies, Dharna, Relay hunger strike, submission of memorandum to Ministers, Members of Parliament, Chief Executive of Banks or any other mode of programs.
- (d) In case you feel relay, hunger strike should be organized during action programs, what should be its format and probable number of volunteers you will be able to mobilize for this purpose.
- (e) Issues to be highlighted in the action programs. (of course, Updation of pension will be the main demand)
- (f) How to ensure better publicity in electronic and print media.
- (g) Financial aspect and suggestion as how to strengthen struggle funds till Updation demand is achieved.
- (h) Any other suggestions.

5. State Committees are requested to send the report in this regard at the earliest, say within period of one month.
