**Re: Joint Meeting of AIPNBRF & UPNBRWA convened by AIBRF  
In Kolkata on 7.09.2025**

Joint meeting of AIPNBRF & UPNBRWA Representatives was convened by AIBRF to review progress made in implementation of various decisions taken on 18.12.2024 while announcing merger/ unification of two affiliates, to consider letters received from UPNBRWA and AIPNBRF pointing out the bottlenecks and practical problems they are facing in carrying out merger / unification decisions at state level/ area committee level.

2. The meeting was attended by 8 representatives from UPNBRWA, 5 representatives from AIPNBRWA and two (President & General Secretary) from AIBRF. On 6<sup>th</sup> September evening sperate discussions were held with the representatives of two organizations to understand their view points on the merger issue and the difficulties coming in the way to take the issue forward.

3. On 7-9-2025 the meeting was addressed by the President & General Secretary, AIBRF emphasizing need of merger/ unification to strengthen bank retiree movement and to serve the membership in better way in post- merger era. Thereafter, GS, AIPNBRF & UPNBRWA spoke and raised the various practical difficulties being faced at state/ reginal level unification. GS, UPNBRWA submitted 9-point memorandum which need to be addressed to take the move forward. It was taken on record for discussion and solution. During the discussion the following points emerged


- (a) All leaders who spoke in the meeting emphasized need for merger/ unification of merger affected affiliates and committed to work for it
- (b) Historical decision to merger AIPNBRF & UPNBRWA on 18. 12.2024 was recalled and welcomed this decision.
- (c) Various decisions taken to implement memorandum signed on 18.12.2024 for merger which have been implemented at the apex level like in AIPNBRF office bearers team 13 office bearers were elected from UPNBRWA, all subscription to AIBRF have been paid through AINBRF in 2025, new 6 state committees are being formed, joint meetings are being held etc. were recalled and appreciated.

4 . It was unanimously decided that to address issues raised in UPNBRWA letter and find acceptable solution, detailed discussions are needed with the representatives of both organizations. It was decided that for this purpose one committee is constituted under the chairmanship of President, AIBRF Shri S. M. Deshpande and two representatives from each organization who will study in depth the issues raised and work out acceptable solutions thereof. The committee is expected to complete the task latest by 31.01.2026.

5. The meeting ended in very cordial atmosphere
