**Despite many attractive features in New India Super Top policy for bank retirees, one quarries which is being raised by the retirees and genuinely so that in case target of 10000 is not achieved up to the appointed date of 23.10.2017, the proposed policy may not become operational and they may be deprived of joining another option. We appreciate the concern of the retirees.**

**2. In this regard, we may mention that we have taken feedback from the insurance company/ pragmatic insurance broking on flow of applications under the scheme so far. We are happy to inform you that there is tremendous response from all parts of the country and there is very good flow of applications on day to day basis. In view of this we do not anticipate any problem in achieving the target of 10000 and in fact we expect to cross it substantially.**

**Further we understand that the proposal forms received are being scrutinised on day to day basis and data base being created for issuance of health card to the retirees. Wherever deficiencies found, the concerned retirees are being contacted for necessary correction.**

**3. We may further advise that in view of festival holidays between 18 to 21<sup>st</sup> October, 2017 the insurance company has agreed to accept all the applications despatched by speed post up to 23.10.2017 but reaching at Pune after this date.**

**4.We propose to make lump sum payment of premium to New India Assurance Company Limited on 27<sup>th</sup> October, 2017 so policy become operational from 1<sup>st</sup> November,2017**
