**Re: Super Top Policy of New India for Bank Retirees**

**We request you to refer our last circular 2017/115 dated 27.10.2017 on the subject.**

**2. We wish to inform the latest position on Super Top Policy of New India as under**

**(a) Premium of the cheques realised have since been paid to New India Assurance Co. Limited and Super Top Policy has come in to force from 01.11.2017. It may be advised that the retirees whose accounts have been debited, their risk under super top policy stand covered.**

**(b) Some of the cheques have been returned unpaid by the paying banks for reasons like signatures differ, insufficient balance post dated ,stop payment etc. The concerned retirees are being advised through e-mail. They are requested to send fresh cheques with Rs. 236 being cheque return charges in addition to the prescribed premium payable for super top policy.**

**(c) We understand from 01.11.2017, United India has changed some TPAs for base policy. New India is collecting the latest list of TPAs. List of TPAs is likely to be released by 20.11.2017.**

**(d) New India policy will be ready in next 10 days which will be placed on aibrf web site with detailed terms and conditions.**

**(e) List of retirees covered under the policy will be ready in next 10 days and will be displayed on the web site.**
