**Re: Supreme Court Judgement dated 16.05.18
On 100 per cent DA**

As informed to you vide our circular no 44 dated 15.05.18, today Supreme Court has delivered the judgment in the matter of 100 per cent DA. Copy of the judgment is enclosed for your ready reference.

2. As per the judgement, the Court has reversed the judgment of Kolkata High Court which was in favour of retirees and upheld the Madras High Court judgement which was against the retirees. In nutshell, the judgment has gone against the retirees.

3. It has come as big shock for the retirees. We were quite hopeful as the events took place during the hearing. On the basis of arguments presented by our senior council and documentary evidence presented, the bench took unusual decision to recall dismissed SLPs filed by retirees against the judgement of Madras High Court. This development raised very logical hope among retirees that the bench find strong merit in our arguments which made them to take unusual decision of recall. But now we find that the recalled SLPs have been dismissed second time without giving reasons to do so.

4. We do not find any mention in the order on various arguments lead by our senior council and also no mention of IBA administrative circular creating discrimination not permissible under law.

5. These are our instant reaction. We are studying and analysing the judgement in depth to decide our future course of action including feasibility of filing review petition and its usefulness and effectiveness to get justice. We shall take final call in the matter in consultation with members of core committee/ Legal Committee and as per the advice of our senior council.

6. We know all our membership must be feeling sadden with this judgement. It is natural. It is also hard fact that this adverse judgement from the highest court of the country has significantly reduced our options. But it is not the end of the tunnel. AIBRF shall continue to take all possible steps to secure justice for retirees on this issue through legal/ organisational steps.
