REGISTRATION OF DELEGATES & OBSERVERS

It will not be possible to accept names after 10.02.2019 under any circumstances in view of the constraint in arranging accommodation at the last movement in the city of Delhi.

CONDUCT OF CENTRAL COMMITTEE

Central Committee meeting has been convened on 28.02.2019. It will be short duration meeting. Main business to be carried out will be adoption of GS Report to be presented in Delegate Session on behalf of the Central Committee. To have meaningful discussion on the report we are taking following steps: (a) We shall make efforts to send soft copy of the report to office bearers and central committee members latest by 15.02.2019. (b) Office Bearers and Central Committee Members are requested to send their views/ comments in three parts. Modifications: Needed quoting specific Para and giving reason for it. Additions: Any point not covered needed addition. Deletion: Any removal needed. We request you to send such feedback to reach central office latest by 20.02.2019 for further action on them in time so report can be adopted within limited time available.

CONDUCT OF PROCEEDINGS IN BUSINESS SESSION OF GENERAL COUNCIL
