**We wish to invite your kind attention on various communications sent to you in the matter of renewal of group medical insurance policy for retirees for the year 2018-2019 to resolve the issue of unprecedented increase in premium by UIICL for the renewal to ensure continuance of the policy at reasonable premium.**

**2. As informed to you from time to time, we are in touch with UFBU leadership and also working in close coordination with CBPRO leadership. We are happy to note that UFBU has raised the issues of retirees for renewal of the policy in very effective manner in the meeting of 8<sup>th</sup> August,18 with IBA. Copy of the circular issued by AIBEA on the subject is enclosed for your ready reference. We have already forwarded to you Joint Communication issued by CBPRO & AIBRF giving the development.**

**3. As per the above circular UFBU leaders will again meet IBA on 18.08.2018 where this issue will be again discussed. We and CBPRO representatives are likely to meet UFBU leaders on 17.08.2018 to discuss the matter with them and place our view points before them for taking up with IBA. Earlier meeting fixed on 8<sup>th</sup> August, 2018 with UFBU leadership to discuss the matter could not take place due to unavoidable personal reason.**
