This is the official position of AIBRF. We would like our affiliates, office bearers, central committee members, activists to take note of it. We request all of you not only take very firm note not to circulate such messages onward but to condemn them in strong words under advise to Central Office. We are sure we shall get full cooperation from all of you in this regard. We also request to show full faith in the organisation.
