Re: 4th Triennial Delegate Session of AIBRF

As you are aware, the decision was taken at central committee meeting held at Hyderabad on 2nd & 3rd Dec. 2014 to postpone dates of 4th Triennial Delegate Session by about 6 to 8 months and accept invitation of AKBRF to hold the same in the state of Kerala.

2. Subsequent to Hyderabad C.C. Meeting, the major development taken place in respect of wage settlement is signing of MOU between the parties and as per terms of MOU final agreement is likely to be signed by end of May, 2015 including on pending pension related demands which affect retirees and for which we have been engaging ourselves actively for last 3 years.

3. In view of this development, we have started making preliminary preparations to hold next delegate session somewhere in the month of November, 2015 in Kerala. We expect to issue formal notice for the delegate session giving exact dates and venue by middle or end of June 2015 so travel plan can be finalised by the members well in time before new time period of 4 months for railway reservation begins.

4. As per the provisions of the constitution each affiliate is entitled to nominate delegates at the rate of one for each block of 100 primary members with maximum 50. To calculate the exact number of delegates for the next delegate session, cut off date to count membership will be 31st December 2014 and subject to clearance of annual subscription for 2015 based on the membership on the above cut off date latest by 30th September, 2015 failing to which the affiliate will not be eligible to nominate the delegates which please note.

5. We propose to allow affiliates to nominate observers to attend the delegate session at the rate of one for each block of 500 members subject to minimum ONE and maximum 10.

6. we shall feel highly obliged if you can indicate tentative number of delegates and observers you would like to nominate as per the entitlement for your unit and how many you expect them to attend the conference to enable the host unit to make proper and effective planning for comfortable stay arrangements well in advance. It will be very nice of you if you can supply this information latest by 31st May 2015.

7. We are planning to keep delegate session for two and half days. First day evening will be for open session and next one and half days for business session.

8. As per the practice prevailing and to meet requirement of the constitution General Secretary will be presenting the comprehensive report in the business session. In case the office bearers and central committee members have any specific issues or points to be included in the general secretary report they may send their suggestions/ inputs for our consideration latest by 30th September, 2015.

9. Host unit is planning to come out with Souvenir publishing various information/ articles concerning retirees/ senior citizens .Those who want to send any related material in this connection may send in coming days. We shall advise full details in this regard in due course. Publication of Souvenir will also be part of fund raising programme to meet expenses of the delegate session. We expect each affiliate to extend all support in securing advertisements from banks and other members of the public. Details in this regard will be submitted in due course.

10. Delegate Session will take up constitutional amendments needed and consider passing some resolutions concerning retirees and on other important current issues. In case any office bearers / central committee members want to send any material/ suggestions in this regard may do so latest by 30TH September, 2015.

11. We appeal to all our affiliates office bearers central committee members, state body chiefs activists, primary members to extend all possible support to make 4th Triennial Delegate Session a grand success to make the organisation more strong and vibrant and take the retiree movement
