Re: Formation of Coordination Committee of Bank of Baroda, Dena Bank and Vijaya Bank Retiree Organisations

Meeting of representatives of 3 banks was held in Pune on 21.08.2019 to give final shape for constituting Coordination Committee of 3 retiree organisations in order to effectively handle retiree issues in coordinated manner in post-merger environment. The meeting was presided by the President of AIBRF and General Secretary AIBRF also attended to play role of facilitator.

- 2. In very cordial and positive atmosphere, the following decisions were taken to serve retirees in post-merger scenario and to display strong unity among three organisations under banner of AIBRF.
 - (a) Two level coordination committees will be formed one at All India level and 18 Zonal Committees to adjust with administrative setup of Bank of Baroda.
 - (b) Apex level committee will be known as "ALL INDIA COORDINATION COMMITTEE OF BANK OF BARODA DENA BANK AND VIJAYA BANK RETIREE ORGANISATIONS- AFFILIATED TO AIBRF"
 - (c) 18 Zonal committees will write Zonal words in their names.
 - (d) All India Committee will have 12 members to be nominated by three organisations in the ratio of 4 each.
 - (e) In all India Committee out of 12, 6 will be office bearers and 6 will be members of the committee. In each zonal committees there will be 6 members to be nominated by three organisations in the ratio of 2 each.
 - (f) At all India level, office-bearers positions will be Chairman, President, Convener and 3 joint conveners.
 - (g) The Committee will be responsible to liaise with the bank management for resolution of pending issues, to take up demands of retirees and to ensure that grievance redressal mechanism work effectively at all levels, supervision of functioning of zonal committees and to take all steps to move towards complete integration of 3 organisations in phased manner.
 - (h) Convener will be functional position and he will be responsible to initiate correspondence and follow up with the management, with 3 retiree organisations and outside agencies, convening meetings and maintaining records etc. However all policy decisions will be taken up after consultation and concurrence with the Chairman and President.
 - (i) Three members sub-committee was constituted to prepare by laws/ constitution for functioning of all India and zonal level committees.

- (j) Zonal Committee will be set up in next 3 months.
- (k) Meeting of the all India and zonal committee members will be held in next 6 months to finalise future action plan, approval Bye-laws etc,
- (l) As decided earlier three existing retiree organisations will continue to function independently of course in coordination with all India / zonal level coordination committees.
- 3. The following Office bearers were elected in the meeting
 - (a) Chairman- Shri Rasik Acharya Dena Bank
 - (b) President Shri Kalyan Sengupta- Bank of Baroda
 - (c) Convener- Shri Vishwnath Naik-Vijaya Bank
 - (d) Jt. Convener- Shri Subhash Purohit Bank of Baroda
 - (e) Jt. Convener- Shri Kishore Gujarati Dena Bank
 - (f) Jt. Convener- Shri Sudhakar Shetty- Vijaya Bank
- 4. Names of the all India committee members will be finalized and communicated shortly. All above decisions were taken unanimously.
- 5. The combined membership of the coordination committee will be around 16000 plus and now has 7 office bearers and 22 central committee members in AIBRF.
- 6. We consider it as historical and important step to take the retiree movement under banner of AIBRF forward and may become role model to successfully tackle other mergers which are likely to happen in coming days.
- 7. We convey our thanks to the leadership of 3 organisations for displaying maturity and unity for the cause of retiree movement. We also thank Dr. G.S. Jog organising secretary for making excellent arrangements for the meeting.
