**Dear Comrades**

**Re: Proceedings at RLC on 28.02.2017**

**The meeting was attended by 7 representatives of AIBRF and 2 representatives of IBA were present. AIBEA and AIBOC did not attend the meeting and had sent letters advising that they were unable to attend it in view of strike call on the day.**

**We made the following submissions lasting for 70 minutes in continuation of our submission made during the last meeting on 24.01.2017.**

- (a) We had drawn the attention on the provisions of Pension Regulations No. 35, 36 & 37 which deal with computation of basic pension and dearness allowance. They have not been properly implemented by IBA/ Banks as per the provisions**
- (b) We had drawn the attention that under 8<sup>th</sup> wage settlement, benefit of improved dearness relief to pre- November 2002 was denied by issuing administrative instruction without any specific provisions in the settlement in this regard. We questioned validity of administrative instruction in the absence of any settlement in the matter.**
- (c) We had questioned validity of clause no 16(3) of the settlement of 2010 where this clause was inserted with retrospective effect to deny benefit of improved DA to pre-November 2002 retirees.**
- (d) We had drawn attention of the Presiding Officer that IBA had made commitment to dispose of pending issues of retirees in the Record Note dated 25.05.2015, This commitment was further confirmed by IBA in various communications in last one and half year. But now it is disowning it in the name of absence of mandate. IBA should be asked to dispose of retiree issues as per the commitment given in the Record Note.**
- (e) We also pointed out that our submissions are basically for implementation of various provisions of the settlement where there are blatant violations and not opposing the settlement.**

**IBA representatives had submitted that issues raised by AIBRF have already been dealt in the judgement of division bench of Madras High Court and confirmed the validity of provisions of the settlement. They further pointed out that Supreme Court in its recent judgement has refused to interfere in the judgement of**
