We wish to invite your kind attention on IBA letter No.HR & IR / Misc./SKK/ MBRCC/8628 dated 3.2.2020 addressed to Shri S.M. Sehaeysayan on the subject of pending retiree issues. (Copy enclosed)

- 2. We are very much surprised to see the contents of this letter which we feel are highly insensitive and to large extent humiliating for retirees who have been patiently struggling fighting for their issues for last 25 years and most of them are 70 and above and many are super senior citizens. We do not know whether contents of this letter are technically correct or not, but it blatantly demonstrates strong disrespect to bank retirees.
