All India Bank Retirees' Federation and its more than 1, 50,000 convey their sincere thanks to you for pursuing issues of bank retirees at various levels relentlessly for last several years.

2. Your efforts as Chairman of the Parliamentary Standing Committee on Personnel Grievances, Law & Justice as well as on individual basis have given pointed focus to the pending issues of the bank retirees. They have been brought to the notice of IBA and other authorities in highly effective manner. We are confident that the steps taken by you would help in resolving the issues in coming days. We convey our appreciation for showing concern to the issues of senior citizens belonging to the banking industry.

3. In this regard, we wish to invite your kind attention on recent letter of IBA No.HR & IR/KSC/GOVT/85/63 dated 13th April, 2016 addressed to you wherein IBA has come out with its stand on retiree issues, in particular giving the reasons as to why IBA is not able to hold discussion with the representatives of bank retirees.

4. IBA has cited two main reasons in the above referred letter for not holding discussion-one is that it does not have specific mandate from the member banks and second that there are many retiree organisations without any prescribed procedure to verify majority status of a particular organisation.

5. On this subject, we wish to mention that the stand taken by IBA as stated in the above letter is purely technical and not based on correct facts. We may also state AIBRF has also received letter on similar lines from IBA sometime back. In response to these communications of IBA, we have written detailed letter No. 2016/410 dated 6.05.2016 highlighting the factual position in this regard and coming out with logical analysis as to why IBA should
