Re: Decisions taken in Office Bearers Meeting held on 19.12.2020
Re: IMPLEMENTATION

You will kindly recollect that unanimous decision was taken in the recently held office bearers meeting that to achieve speedy sanction of pending proposals of retirees from the government, AIBRF will launch follow programs at the various levels during next 3 months.

Accordingly, follow up programs of AIBRF commenced from 24.12.2020, Details of which are as under:

(A) AIBRF DELEGATION MEETING IBA CHAIRMAN IN BANGALORE ON 24.12.2020

AIBRF delegation consisting of **DGS. Shri Vishwanath Naik, Organising Secretaries, Shri Venkatrao and Shri Abdul Jalil met IBA Chairman Shri Raj Kiran Rai in Bangalore on 24.12.2020** and submitted the enclosed memorandum to him with the request that IBA should take steps to secure required approval from the government on pending issues including updation at the earliest . While accepting memorandum from the delegation, he assured that IBA is fully aware of the aspirations of Bank Retirees and that the IBA will do everything required to be done in this direction. He was very cordial to our delegation and it was with a very positive note.

Since the appointment was given quickly at the short notice, in the present situation it was not possible for the General Secretary to reach Bangalore.

(B) AIBRF DELEGATION MEETING HONOURABLE CENTRAL CABINET MINISTER FOR SOCIAL JUSTICE AND EMPOWEMENT SHRI TAWAR CHAND GEHALOT IN INDORE ON 24.12.2020

The Central Cabinet Minister Shri Thawar Chandji Gehalot, Social Justice and Empowerment was kind enough to agree to meet AIBRF delegation on 24.12.2020 in VIP Lounge at Indore Airport. AIBRF delegation led by the General Secretary. Other members of the delegation were AIBRF treasurer, Shri Sunil Pradhan and two other local activists. He was very cordial and positive in receiving the delegation and accepted the

memorandum with assurance that he would personally look into the pending matters for their early disposal in particular the proposal of increase in ex-gratia payment to pre-1986 retirees. **He observed that they all are 93 plus in the age and nation should feel proud on it.**

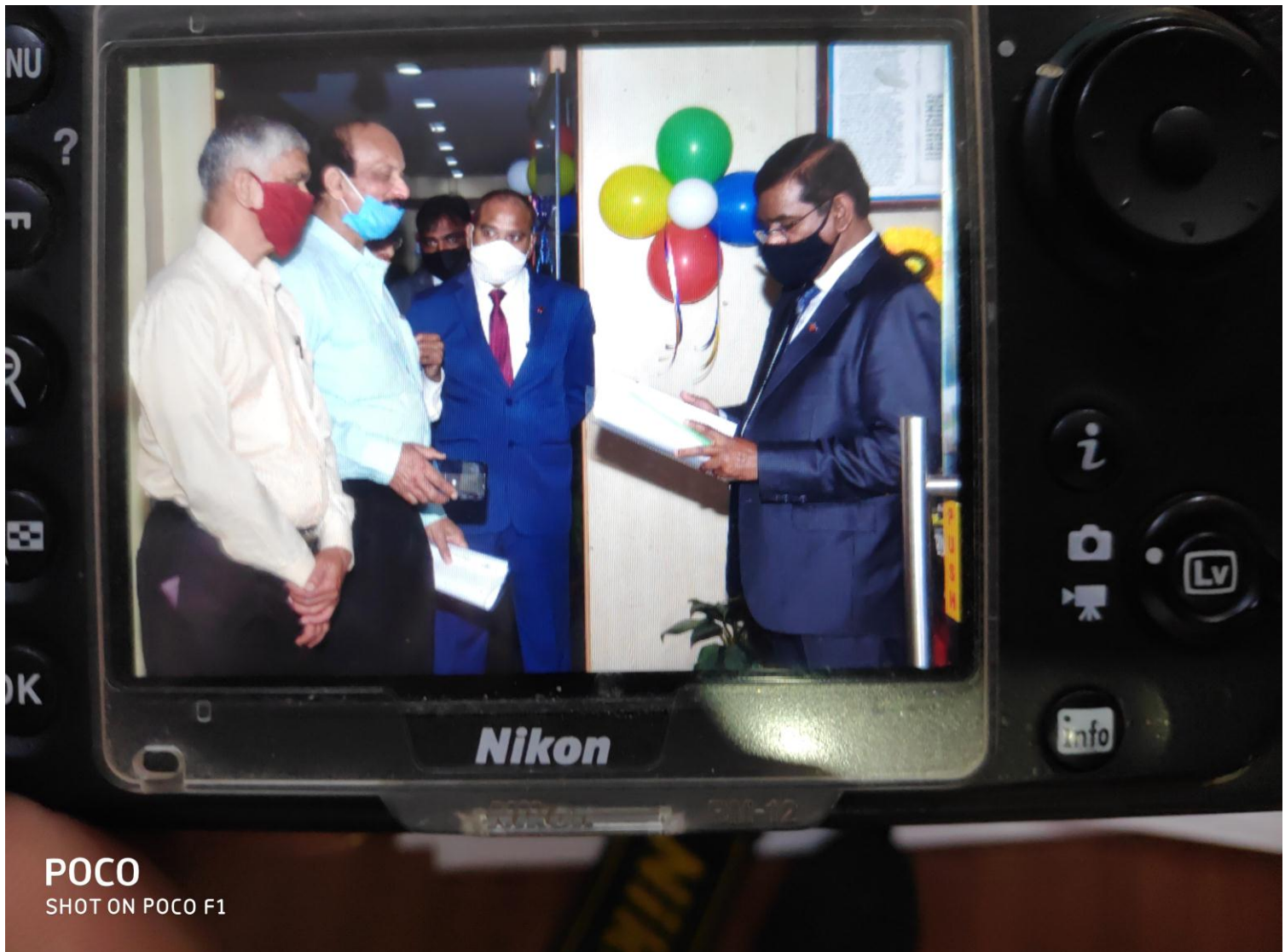


Photo of AIBRF delegation meeting IBA Chairman in Bangalore on 24.12.2020

Advice/ Instructions to State Committees /Affiliates for continuance of follow up programs at various centers in coming days.

We request you to refer our circular **No. 2020/472 dated 21.12.2020** conveying the decisions taken in office bearers' meeting held on 19.12.2020.

We below give plan for implementation of decisions as follow up measures in **next two months**:

- (a) SUBMISSION OF MEMORANDUM TO CENTRAL MINISTERS AND MEMBERS OF PARLIAMENT.**

It was decided that memorandum will be submitted to **Central Ministers and Members of Parliament** with the request to them to intervene to ensure early sanction from the government on pending proposals of bank retirees. We are now pleased to enclose **draft of the memorandum** to be submitted by state committees in the respective states on behalf of AIBRF.

In view of this state committees are requested to chalk out the plan and submit the enclosed memorandum with the covering letter from state committee to as many M.Ps. possible in their states. On submission of the memorandum the report on it may be sent to the central office.

After issuance of the above referred circular, the following state committees have informed us that they are planning to submit memorandum to the following number of Central Ministers and members of Parliament

It was decided to ask state committees to convene meetings and explain the latest development on Updation and other pending issues to members so the confusion if any prevailing can be cleared and proper climate can be created for our further follow up programs.


