In continuation of our circular no 2020/491 dated 15.02.2021, we are happy to present 6th report on Follow Up Action programs carried out by state committees after 15.02.2021.

During this period AIBRF delegations met and submitted memorandum to honorable Finance Minister, Smt. Nirmala Sitaraman in Kerala on 28.02.2021 and to Secretary, Department of Financial Services, Shri Debasish Panda in Delhi on 23.02.2021 Brief Reports submitted by the delegations on these two meetings are as under

1.SUBMISSION OF MEMORANDUM TO HONORABLE FINANCIE MINISTER SMT. NIRMALA SITARAMAN IN KERALA ON 28.02.2021 BY AKBRF.

AKBRF team under the leadership of the Chairman of AIBRF submitted a memorandum to Finance Minister Smt. Nirmala Sitaraman on 28th February 2021at Cochin- Kerala at 3.30 pm.

The Chairman explained the problems of retirees for which the FM have a patient hearing and assured that she will definitely look into the matter: and quipped - "otherwise what will happen to my assurances?"

Com. K. Sreenivasan also requested Finance Minister to follow up further directly with IBA to which she expressed her assent.

AIBRF delegation from U.P State Committee led by Shri R.K. Agrawal met IBA Chairman in Lucknow on 20.02.2021. This was the third occasion when AIBRF delegation met and submitted memorandum to IBA Chairman on pending issues of retirees THIRD TIME in last 3 months. Report received from U.P. State Committee is as under.

he MD was very frank & forthright in his discussions. he informed that though an amount of 220,000 crores was the burden on family pension, he had recommended the same to ministry, where a note had also been prepared & moving forward.

On pension updation issue, he himself said that it brought tears looking to the pathetic condition of pre- 2002 retirees who were not even getting 100% DA neutralization. he said he would try to give this benefit & also trying to update pension. He was studying various options including RBI formula, according to him. He informed that the cost of pension updation had gone up considerably as interest rates were coming down. he said actuary in his own bank had pegged the pension cost provision to be around 21000 crores. he referred to 2018 report. he also referred to a recent report obtained where the updation cost was substantially higher. he said he was trying to obtain another report from some other actuary where the pension cost could be lesser.


