should be sent by Speed Post on his address.**
- (7) All directors should be requested to raise the issue in the Board
meeting for suitable decision**
- (8) Special request should be made to workman director and officer
director to seek their support on the issue.**
- (9) We want that this action programme should be successfully
implemented during the months of May & June 2017**

Office for record and follow up.**
