Re: Office Bearers Meeting at Mumbai 16th & 17th July,14

It has been decided to hold Office Bearers Meeting at Mumbai on 16th and 17th July, 2014 to take stock of the developments taken place concerning retirees and form strategy for coming days and also to discuss organisational matters.

2. Bipartite negotiation on wage settlement is on hold since 14-03-214 as the nation was in election mode so far. Now new government with different ideology and philosophy has come in power at the centre. Recently, RBI has released report of Nayak Committee which has recommended virtual privatisation of public sector banks. What will be the impact of these developments on the bank retirees, on their issues and ongoing wage settlement? We propose to deliberate them and formulate our strategy in view of changing scenario. We shall circulate formal agenda of the meeting shortly.

3. It is the meeting of office bearers. Therefore no observer or substitute will be permitted. However, some affiliates with membership of more than 1000 like Syndicate Bank, State Bank of Patiala who have joined AIBRF in recent past and who do not have representation in office bearers will be permitted to nominate one observer from each such affiliate.

4. AIBRF is making lodging and boarding arrangements for the participants for 16th and 17th July, 2014 near Andheri Railway station. Details will be advised shortly. Travelling expenses for the journey will have to be borne by the participants.
